## **FELABRATION ARTWORK COMPETITION TERMS AND CONDITIONS**

1. The organiser is a not for profit entity called Felabration Festival Organising Company Ltd/Gte (“FOC”) (RC no. 1160476) whose registered office is at 1, NERDC road, Agidingbi, Ikeja Lagos
2. The competition is not open to employees of the FOC and their close relatives, or anyone otherwise connected with the organisation or judging of the competition.
3. Entrants under the age of 18 must obtain permission from their parents or guardians before entering.
4. The competition opens on the 1<sup>st</sup> April 2017 and closing date for entry into the competition and submission of artwork is Friday 30<sup>th</sup> June 2017. After this date no further entries to the competition will be accepted.
5. To enter, complete the Felabration Artwork Completion Submission form and send along with your artwork in an email to [info@felabration.net](mailto:info@felabration.net). The email subject should be “Felabration 2017 Artwork Competition”. The artwork may be a drawing, or a piece of artwork created from a picture or photograph and must be submitted in electronic form.
6. The artwork submissions will be evaluated by members of the FOC and any such persons to be determined by the FOC. The top three (3) winners will be announced on [www.felabration.net](http://www.felabration.net), all social media platforms and contacted by a representative of the FOC on or before Friday 31<sup>st</sup> July 2017.
7. The wining pieces will be exhibited by the FOC on the Felabration website [www.felabration.net](http://www.felabration.net), on all social media platforms and displayed at the New Afrika Shrine, Kalakuta Museum and any other venues determined by the FOC.
8. As a participant of the competition, I understand that my artwork submission is on the following conditions:

- 8.1 I understand that the FOC refuses to accept and evaluate my artwork submission in the absence of my acceptance of each and all the terms and conditions stated herein.
- 8.2 I agree to the use of my artwork submission, name, image and likeness in any publicity material for the competition and any Felabration related event by the FOC exclusively.
- 8.3 I hereby grant the FOC a royalty-free, exclusive, and unrestricted license, (with a right to sublicense) to make, have made, use, distribute, execute, perform, copy, display, modify and make derivative works from my submitted artwork in perpetuity.
- 8.4 I represent and warrant that I am the author of the artwork submitted or that I have obtained the consent of the author of any artwork used in my submission; that I am the present and sole owner of all right, title and interest in the said submission or that I have the exclusive, unconditional right and authority to submit and/or convey said material to FOC upon the terms and conditions herein; that no third party is entitled to any payment or other consideration as a condition of the exploitation of the submitted artwork.
- 8.5 The FOC reserve the right in its absolute discretion to disqualify my artwork submission if it has reasonable grounds to believe that I have breached any of these terms and conditions, any applicable law (including copyright law) or has otherwise infringed the intellectual property of any other person.
- 8.6 I agree to indemnify FOC from and against all claims, expenses, losses, or liabilities (including, without limitation, reasonable legal fees and punitive damages) that may be asserted against the FOC or incurred by the FOC at any time in connection with the artwork submitted including without limitation those arising from any breach of the warranties and promises given by me herein
- 8.7 This completion and the terms of engagement are governed by the laws of the Federal Republic of Nigeria.
- 8.8 In the event of any dispute concerning any claim arising in connection with the artwork submitted, such dispute shall be referred to the Lagos Multi-Door Courthouse (“LMDC”) for mediation which shall be conducted in accordance with the LMDC Mediation Procedure Rules or such other rules mutually agreed by the parties. Each party shall bear its own costs and would be liable to contribute the same agreement in respect of fees to be paid to the Mediator.
